
BritCan's investment structure has been designed to provide excellent security with first position recoupment, favourable opt-in-out options and an aim of launching a successful IPO within five years.

# MAKING YOUR INVESTMENT COUNT



BritCan believes that investors come first and so we insist on total transparency and have designed our production investment with this in mind, thus, minimizing the risk factors often associated with production.

The BritCan team will continue to invest along side investors increasing the overall production value and profile of the production slate, to the benefit of all. We accomplish this important goal by adhering to the following measures:

- > Alignment of interests: the BritCan team will co-invest the same amount alongside investors
- Preference shares: 90% of all revenues flow directly to investors without deduction or fees until they have recouped 120% of their investment. The company principals share in the profits only after the investors are made whole and with profit.
- Payment in Kind: Any shortfall in full recoupment and profit is secured by corporate stock, issued at fair market value.
- No outsourcing of distribution: BritCan is its own distributor and thus all revenues are gross dollars as there is no other deductions, thus, managing all incoming distribution revenues.
- Commercially tested before production: Films are chosen for their commercial value first and foremost, verified in the marketplace, before production takes place.
- > Costs of distribution and marketing are covered in full to ensure that the products have marketplace presence.
